#### NAESB AT A GLANCE: MONTHLY UPDATE

**UPDATE ON SMART GRID DATA PRIVACY REQUEST:** Ms. Wright, chair of the Smart Grid Data Privacy Task Force delivered the update on the smart grid data privacy request. She stated that the Smart Grid Interoperability Panel (SGIP) Cyber Security Working Group (CSWG) submitted a request, R12008, to NAESB in August that proposed enhancements to the NAESB Retail Data Privacy Standard REQ.22 in four areas: adding cyber security requirements, improving utility privacy requests, improving customer education, and enhancing the identity verification process. The SGIP CSWG identified the enhancements during the vetting of the standard for consideration in the SGIP Catalog of Standards. In response, the Smart Grid Data Privacy Task Force has been reactivated at the request of the chair of the REQ Executive Committee. The first meeting of the Smart Grid Data Privacy Task Force took place on November 30, 2012 and the participants were pleased to hear from members of the SGIP CSWG. Mr. Booe stated that the Smart Grid Data Privacy Task Force intended to review the CSWG content and create a table addressing the request issue by issue. The next Smart Grid Data Privacy Task Force faceto-face meeting with web conferencing will be hosted by ERCOT in Austin, Texas on February 25, 2013 from 9:00 AM to 4:00 PM Central.

UPDATE ON PUBLIC KEY INFRASTRUCTURE (PKI)/CERTIFICATION EFFORTS: Mr. Booe, Vice-President of NAESB, provided the update on the PKI Subcommittee activities. On November 30, 2012<sup>1</sup>, NAESB filed a status report to the FERC regarding the NAESB PKI Standards development effort. At that time, the PKI Subcommittee had completed two annual plan items during the late summer that had already been modified by the NAESB membership. The NAESB WEO-012 PKI Standards impacted two other subcommittees, the Joint Electric Scheduling Subcommittee and the OASIS Subcommittee who developed ancillary standards to accompany the modifications to WEO-012. The final standards were ratified on December 27, 2012 and NAESB anticipates another filing, related to the NAESB Wholesale Electric Quadrant Version 003 standards report, in January. Mr. Booe stated that NAESB would begin accepting affidavits from pending Authorized Certification Authorities for the current version of standards as amended by the final actions. He stated that the program would not apply retroactively to NAESB WEQ Business Practice Standards, Version 2.1. Ms. McQuade asked what other projects the PKI Subcommittee would address this year. Mr. Booe replied that the PKI Subcommittee will meet to address 2013 WEQ Annual Plan Item 4.a.ii which calls for review of the August 27, 2012 FERC report, "Report on Use of North American Energy Standards Board Public Key Infrastructure Standards" (Docket No. EL12-86-000). The subcommittee will determine which standards changes are needed to be responsive to suggestions made by the FERC. Additionally, the subcommittee will develop and/or maintain standard communication protocols and cyber security business practices as part of NAESB 2013 WEQ Annual Plan Item 4.a.i. which calls for the review of standards to support adequate session encryption [Secure Socket Layer/Transport Layer Security (SSL/TLS)].

UPDATE ON CYBER SECURITY EFFORTS: Ms. McQuade, President of NAESB, provided the update on recent cyber security efforts. She stated that the development of two fact sheets that describe the NAESB cybersecurity related standards, how they are used, to which transactions they apply, and how they affect the markets for both natural gas and electricity were underway. Ms. McQuade informed the participants that NAESB was in contact with the Department of Energy regarding NAESB's recent request that Sandia National Laboratories conduct an assurance assessment of the NAESB standards. It was noted that Sandia National Laboratories had given the Gas Industry Standards Board (GISB)/NAESB Business Practice Standards a clean bill of health twice in She thanked both the Department of Energy and Sandia National Laboratories for their support in ensuring that the NAESB Standards reflect the necessary transactions for the industry.

UPDATE ON OPEN ACCESS SAME-TIME INFORMATION SYSTEMS (OASIS) STANDARDS: Mr. Wood, co-chair of the WEQ OASIS Subcommittee, delivered the update on OASIS Standards. He stated that the

OASIS Subcommittee had been focused on the Preemption and Competition process for several months and expected the standards to be completed in the third quarter of 2013. Regarding the delayed completion date, Mr. Wood noted that the process contained more labor than the subcommittee had previously supposed. He invited interested parties to participate in the February 20-21, 2013 face-to-face WEQ OASIS Subcommittee meeting hosted by Salt River Project in Phoenix, AZ. Ms. McQuade questioned in what manner the Preemption and Competition process had become a greater undertaking than the subcommittee earlier thought. Mr. Wood responded that the process contained many sub-issues such as determining a valid Defender and Challenger, which party has the Right of First Refusal, and who holds the existing reservations. A participant questioned how the Preemption and Competition process would correspond to the fifteen minute scheduling. Mr. Wood replied that the subcommittee was currently debating the pertinent timing issues.

**UPDATE ON DEMAND SIDE MANAGEMENT ENERGY EFFICIENCY EFFORTS:** Mr. Booe apprised the participants of the recent developments in Demand Side Management and Energy Efficiency. He stated that NAESB has begun to participate in the Energy Efficiency Standardization Coordination Collaborative (EESC), formed by ANSI to develop a roadmap to describe all related standards, codes, guidelines, and interactions. NAESB will attend the meetings the Evaluation, Measurement, and Verification Work Group Four, which focuses on energy performance metrics, EM&V, and standardized and portable data collection and reporting. The first face-to-face meeting of the group took place January 22-23, 2013. Mr. Booe thanked Eric Winkler for representing NAESB in this initiative.

UPDATE ON WGQ STANDARDS MATRIX: Ms. Davis, chair of the WGQ Information Requirements (IR) Subcommittee, delivered the update on the WGQ standards matrix. She stated that the NAESB 2012 WGQ Annual Plan Item 1.b called for the reorganization of the NAESB WGQ standards manuals for ease of use. In response, the Joint IR/Technical Subcommittees developed an Excel matrix which categorized over 700 items. Through the process of developing the matrix, the group discovered that many standards applied to multiple topics. Mr. Connor asked how the subcommittee had determined the categories within the document. Ms. Davis replied that the participants had sought out recognizable topics that people would utilize as search terms and noted that the matrix would be posted to the NAESB web page. Mr. Connor questioned whether the hits on the web page would be monitored to determine how useful it would be to the industry. Ms. McQuade explained that there were tools to measure the number of downloads on the page, but the true measure of the document's utility will be what the industry chooses to do with the matrix. Another participant queried whether the matrix would be a suitable aide to refer to the gas reference standards. Ms. Davis replied that the Implementation Guide remained the ultimate authority to rely upon and stated that conflicts between the Implementation Guide and the matrix should be resolved on the side of the Implementation Guide. Mr. Booe asked how long an update to the matrix would take after the upcoming WGQ Business Practice Standards Version 2.1 publication. Ms. Davis replied that the matrix was not a priority for the subcommittees and would be updated as available time presented itself. Ms. McQuade thanked the subcommittees for their hard work on the matrix and commended their accomplishments in creating such a beneficial tool for industry use.

**UPDATE ON THE BOARD RETAIL STRUCTURE REVIEW COMMITTEE (RSRC):** Mr. Minneman provided the update on the Board RSRC. He stated that the RSRC had been created to address the insufficient membership numbers within the retail gas and retail electric quadrants. The NAESB Bylaws require a quadrant to have at least forty voting members and at least four segments. After several meetings, the Committee has recommended the combination of the two quadrants. Mr. Minneman explained that the Board RSRC has begun to focus on issues surrounding the merger, such as segment numbers and matters regarding voting. The next RSRC conference call will be held on February 22, 2013.

**NAESB COPYRIGHT POLICY:** Mr. Booe delivered the presentation regarding the NAESB Copyright Policy.<sup>3</sup> On November 20, 2012<sup>4</sup>, NAESB submitted a report regarding the NAESB Copyright Policy to FERC Docket Nos.

RM 05-5-000 and RM 96-1-000. The report reminded industry members of the existing NAESB Copyright Policy and clarified the parameters for use of the NAESB copyrighted standards in FERC compliance filings and tariffs. Since the filing, NAESB has been pleased to work with companies who have discovered mistakes made when filing their tariff. Several companies have contacted the NAESB office for waivers of use of the standards language in their tariff filings after copyright intrusions were found. Mr. Booe explained that the NAESB staff has been reviewing a number of tariff filings to ensure that companies are not posting verbatim standards without permission. He stated that situations may exist where simply referencing a standard would not be sufficient in tariffs and other filings. In those cases, before using verbatim language, NAESB merely requires that the company attain a waiver and then note in their documentation that the language is included with the permission of NAESB.

CHANGES TO THE NAESB WEB SITE: Ms. McOuade delivered the update regarding the NAESB web site transformation. She explained that NAESB recently acquired a new server, delaying the release of the new web site. The upcoming changes will allow non-members to access current information, while members will have access to the entirety of the web site. She noted that non-member attendees will be assessed a fee to attend NAESB subcommittee meetings. Currently, the NAESB office is testing the modifications to the web site.
